1. **Bimini Bound E&G Giveaway: April 1st – June 30th, 2018**
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNy). Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.
3. Promotion information and rules can be obtained from Genting Rewards and by visiting www.rwny.com.
4. Qualified Genting Rewards members are entitled to the following promotions on the promotion day only.

Eligibility:

- Guests who earn 1,200 tier points on any day between April 1st – June 30th may redeem a free Bimini trip, package A.
- Guests who earn 600 tier points on any day from April 1st – June 30th after purchase an Elite flight may redeem a free Bimini trip, package B.

Bimini Trip Package A:

- \$1,500 value trip per person either 3 weekend nights (Thursday – Saturday) or 4 weekday nights (Sunday – Wednesday).
- Flights out of Newark directly into Bimini. Flight seats reserved on availability; Limited to 300.
- Hotel and Breakfast is included and \$100 Free Play per trip per person.

Bimini Trip Package B:

- Either 3 weekend nights (Thursday – Saturday) or 4 weekday nights (Sunday – Wednesday).

- Trip can only be booked with an Elite flight confirmation.

5. Qualified guests must redeem their voucher at the Genting Rewards Kiosk machines during the promotional earning period when points are earned or voucher will be forfeited.
6. Each guest can redeem 2 trips per month and maximum 6 trips per 12 months.
7. All trips must be booked and redeemed within 90 days of the voucher is printed.
8. Lost voucher will not be re-issued.

9. Guests can book the trip by calling 888.930.8688 from 8 am – 4 pm or book via 5th Ave Club every Friday, from 5 pm – 7 pm.
10. Vouchers are non-transferable. Entries will have player name and account number. Any player that had been barred or excluded will not be eligible for the promotion.
11. Guests can redeem their vouchers at any Genting Rewards kiosk.
12. Only the guest identified on the voucher will be eligible to book the trip. Vouchers presented by a person other than the redeemer will be voided and the guest may be rendered ineligible for future promotions.
13. Malfunction of the Genting Rewards Kiosks or vouchers that do not register must be reported immediately and within the parameters of the promotion time.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
