1. **Earn & Get Scratch-off Giveaway: Wednesdays, May 2nd – 23rd, 2018**
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNy). Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.
3. Promotion information and rules can be obtained from Genting Rewards and by visiting www.rwny.com.
4. First 800 guests to earn 50 points and redeem a voucher can receive a free NY Lottery scratch-off ticket starting from noon – 3 pm on Wednesdays in May.
5. Scratch-off tickets will be distributed at the 1st floor promotion booth.
6. Limited to one redemption per promotion date.
7. Voucher can be redeemed at any operational Genting Rewards kiosk.
8. Malfunction of the Genting Rewards Kiosks or vouchers that do not register must be reported immediately and within the parameters of the promotion time.
9. Only the guest identified on the voucher will be eligible to claim the scratch-off card. Vouchers presented by a person other than the redeemer will be voided, and the guest may be rendered ineligible for future promotions.
10. Points are non-transferable and have no cash value.
11. Cannot be combined with any other offer.
12. It is the responsibility of the guest to ensure that their card is properly inserted and that the system identifies them appropriately.
13. All vouchers are void at the end of each designated promotion day.
14. Falsification of any information renders the guest ineligible for the rewards and forfeits any claim to the reward.

Eligibility: The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Division of Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultation, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a

video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of RWNY, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

16. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
