1. **Payday Cash Drawing: Fridays, May 4th – 18th, 2018**
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY). Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.
3. Promotion information and rules can be obtained from Genting Rewards and by visiting www.rwny.com.
4. Qualified Genting Rewards members or guests are entitled to the following promotions on the promotion day only.

Earning Period:

- Guests can earn entries daily from May 1st – May 18th. Entries can be redeemed Saturday – Thursday between 10 am – 6 am, and on Fridays between 10 am – 8 pm.
- Guests may print out 1 entry for every 50 points earned from any Marketing Kiosk (maximum 5 entries per day) during the time stated above.
- Drawings will take place on Fridays, May 4th, 11th, & 18th, 2018.
- Guests can choose any drawing date to deposit their entries.
- Guests can deposit as many entries as they wish on each drawing date.
- All guests are responsible for their entries, lost or misplaced entries will not be reissued.

Drawing: 5 pm – 9 pm

- Drawing drum will open at 4 pm at the 2nd Floor Genting Rewards Club and close at 9 pm on each drawing date.
- Five names will be drawn on the top of every hour from 5 pm – 9 pm.
- Guests have 5 minutes to claim their place at the 2nd Floor Genting Rewards Club.
- Limited to 1x win for the promotion day. All repeated names that were pulled will be redrawn.
- All unclaimed places will not be redrawn.
- Must be present to win.
- Prizes will range from \$500 – \$2,000.

5. Entries are non-transferable. Entries will have player name and account number. Any player that had been barred or excluded will not be eligible for the drawings.
6. Winners must present a valid state or federal issued photo identification or passport to claim their prize. Winners are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any gift or prize. Winners must also present proof of their Social Security Number or complete a W-9 or similar document to comply with Federal tax reporting requirements.
7. Guests can redeem their vouchers at any Genting Rewards kiosk.
8. Only the guest identified on the voucher will be eligible to claim the gift. Vouchers presented by a person other than the redeemer will be voided and the guest may be rendered ineligible for future promotions.

video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of RWNY, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

17. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any reward.
