1. **RW 6th Year Anniversary Drawing: October 27th & 28th, 2017**
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY). Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.
3. Promotion information and rules can be obtained from Genting Rewards and by visiting www.rwny.com.
4. Qualified Genting Rewards members are entitled to the following promotions on the promotion day only.
5. All guests who earn 60 points will receive a free entry to the drawing starting from 3 pm – 7:45 pm on each promotion date.
 - Up to 6 entries can be earned daily after each point requirement is met.

- Drawing drum will open at 2pm at 1st FL promotion booth.
- Six (6) winners will be drawn on top of the hour to spin the wheel to determine their prize between 3 pm – 8 pm.
- A total of 36 winners will be located on each promotion date.
- Guests have 5 minutes to claim their place at the at 1st FL promotion booth.
- Any unclaimed places will be forfeited.
- Each winner will get to spin the wheel in the order their names are announced to share assorted prizes valued between \$500 – \$3,600.
- Limited to 1x win for each promotion date.
- Guests must be present to win.

6. Entries are non-transferable. Entries will have player name and account number. Any player that had been barred or excluded will not be eligible for the drawings.

any fees that may be imposed in connection with the acceptance of any gift or prize. Winners must also present proof of their Social Security Number or complete a W-9 or similar document to comply with Federal tax reporting requirements.

8. Guests can redeem their vouchers at any Genting Rewards kiosk.
9. Only the guest identified on the voucher will be eligible to claim the gift. Vouchers presented by a person other than the redeemer will be voided and the guest may be rendered ineligible for future promotions.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.
16. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any reward.
17. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations and procedures of the promotion.
