1. **Spielo WuFu Fortunes Wheel: Saturday, February 17<sup>th</sup>, 2018**
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY). Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.

4. Qualified Genting Rewards members are entitled to the following promotions on the promotion day only.
5. All guests who earn 88 points will receive a free entry to the drawing starting from 10 am – 6:45 pm on promotion date. A maximum of 8 entries can be earned.

**Drawing: 3 pm – 7 pm**

- Drawing drum will open at 2 pm at 2<sup>nd</sup> floor Genting Rewards.
- Three (3) winners will be drawn on top of the hour to spin the wheel to determine their prize between 3 pm – 7 pm.
- A total of 15 winners will be located on the promotion date to spin the wheel.
- Guests have 5 minutes to claim their place at the 2<sup>nd</sup> floor Genting Rewards Counter.
- Any unclaimed places will be forfeited.

6. Entries are non-transferable. Entries will have player name and account number. Any player that had been barred or excluded will not be eligible for the drawings.
7. Winners must present a valid state or federal issued photo identification or passport to claim their prize. Winners are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any gift or prize. 8. Guests can redeem their vouchers at any Genting Rewards kiosk.

lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of RWNY, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

18. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any reward.
