1. **Baccarat Club Cash Drawing:** Sunday, March 7, 2021.
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and 18 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.

4. Qualified Genting Rewards members are entitled to the following promotions on the promotion dates only:

### **Earning Period:**

- Guests who play and earn 88 points at the Baccarat Club on March 1 through March 7 will receive one (1) virtual entry. Point earning cutoff time will be at 5:30pm on Sunday, March 7, 2021.
  - Guests can earn multiple entries after every 88 points earned.

### **Drawing 6pm**

- Drawings will be conducted through the Lucky Draw Virtual Drum System.
- A total of five (5) winners will be called on the promotion date.
- All prizes will be given from lowest to highest value starting with the first name drawn.
- Winner's names will be announced via the PA and posted at the Baccarat Club.
- Limited to 1x win for the promotion day.
- Repeated names will be redrawn.
- Guests will have 15 minutes to claim their prize at the Baccarat Club on the Fifth Ave casino.
- Any unclaimed prizes will be awarded to one winner to be drawn at 6:30pm; One (1) winner will be drawn every 5 minutes until a winner is located.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.
13. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in
