2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY).
Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.
3. Promotion information and rules can be obtained from Baccarat Club and by visiting www.rwny.com.
4. Guests who play on any Baccarat game throughout RWNYC during each earning period and earn the highest points at the end of the designated earning period will be eligible to receive a \$1,000 cash voucher.
 - a. Eligibility for cash voucher will be based on rated play.
5. Earning period starts Sunday through Wednesday on the following dates below:
 - Sunday, 3/07 – Wednesday 3/10; Redeem for voucher Friday, 3/12
 - Sunday, 3/14 – Wednesday 3/17; Redeem for voucher Friday, 3/19
 - Sunday, 3/21 – Wednesday 3/24; Redeem for voucher Friday, 3/26
6. The top 10 earners will be determined at 10pm each Wednesday, and will be notified via email and phone to redeem their cash voucher from Baccarat Club.
7. All top point earners will be able to claim their \$1,000 cash voucher the immediate Friday after the weekly earning period.
8. Any unclaimed cash vouchers will be allocated to the following week, where additional qualified guests will be made eligible.
9. It is the responsibility of the guest to ensure that their corresponding information is up-to-date in the system including email address and contact number.
10. Cash voucher must be redeemed in person within the hours between 10am – 6pm on the designated redemption date at the Baccarat Club.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.
17. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
