



Birthday Slot Tournament
Eligible Tournament Dates in February, 2019
Time Varies based on Tournament

1. **Birthday Slot Tournament:** Eligible Tournament Dates in February, 2019.
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY). Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.
3. Promotion information and rules can be obtained from Genting Rewards and by visiting www.rwny.com.
4. Participant must be a Genting Rewards card member and have a PIN# attached to their account to access the Genting Rewards kiosk.
5. Offer is extended to guests who have a birthday in February, and they can print out one single entry on any tournament day they choose to participate.
6. Voucher needs to be presented to a promotions representative with valid photo identification to be entered into the slot tournament. The voucher is retained by the representative after redemption.
7. Guests can only print out one entry in their birthday month.
8. All rules for the particular tournament they choose are still applicable.
9. Limited to 200 Birthday redemptions each tournament date in the month of January.
10. Malfunction of the Genting Rewards Kiosks or vouchers that do not register must be reported immediately and within the parameters of the promotion time.
11. Cannot be combined with any other offer.
12. Guest is limited to once redemption on promotion date.
13. Players who qualify in multiple ways, may only enter tournament one time only per day.
14. It is the responsibility of the guest to ensure that their card is properly inserted and that the system identifies them appropriately.
15. Points and vouchers are non-transferable and have no cash value.
16. All vouchers are void at the end of each designated promotion day.
17. Falsification of any information renders the guest ineligible for the rewards and forfeits any claim to the reward and may render the individual ineligible for future promotions.
18. Eligibility: The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Division of Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor,

licensee, registrant or consultation, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of RWNY, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

19. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any reward.
20. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations and procedures of the promotion.
